1. Kindly note that Judge Y Wade AJ will be presiding over the Trial Default Judgment Court next week Monday to Friday in court 4D.
2. Matters will be heard in person from 10H00 unless otherwise indicated.
3. Removals and postponements should be communicated by making a note thereof on CaseLines in the right-hand column, **and** forwarding an e-mail to Ms A Mashala-Shiburi, as soon as Counsel/Attorney becomes aware thereof, at the following e-mail address:- AMashala-Shiburi@judiciary.org.za.
4. Please specify in the right hand corner on CaseLines precisely where the Honourable Judge will locate the parties':-
 - 4.1 Respective Practice notes, if applicable;
 - 4.2 Proposed Draft Order;
 - 4.3 Default Judgement Application, including the relevant applications in terms of the Rules of Court to substantiate that the Court has jurisdiction to determine the quantum of General Damages (if applicable), considering hearing the matter by way of affidavit/s and considering hearsay evidence. Failure to have placed the relevant applications before the Court will result in the matters being struck off;
 - 4.4 Where Contingency Fee Agreements are applicable, where the relevant agreements and affidavits are to be located.
5. Please ensure that you check for any notes made on CaseLines by the Judge BEFORE commencement of the hearing. Should there be significant prospects of settlement, please advise the court by similarly sharing a note on CaseLines.

6. Proceeding will commence with postponements, removals and stand downs. Thereafter matters will be heard according to seniority of the Counsel/Practitioner appearing in the matter. Matters will not be allowed to stand down beyond 12H00.
7. For matters that will be heard on Monday 18 September 2023, practitioners are requested to upload the Heads of Argument, Practice Note and the proposed Draft Order (in both PDF and MS Word formats) onto CaseLines in a separate created section by 16H00 on Friday 15 September 2023.
8. For matters that will be heard from Tuesday to Friday, practitioners are requested to upload the Heads of Argument, Practice Note and the proposed Draft Order (in both PDF and MS Word formats) onto CaseLines in a separate created section by 12H00 a court day before the set down.
9. The Draft Court Order should set out the date of hearing, Judge's name (i.e Justice Wade AJ), whether the Contingency Fee Agreement has or has not been concluded, as well as the names, details of Counsel/Practitioner and those of the instructing attorney, and the attorney's reference number should appear at the end of the Proposed Draft Order.
