JUDICIAL CASE MANAGEMENT CONFERENCES BEFORE VAN DER SCHYFF J FOR THE WEEK 5 to 9 OCTOBER 2020

Kindly note that the following procedure will apply in Judicial Case Management Conferences enrolled before Van der Schyff J during the week 5 to 9 October 2020:

- [1] Only matters which have been registered on CaseLines and of which documents have already been uploaded; and/or matters where the court file has been received from the Registrar, will be considered.
- [2] A fully completed Form 10 (as attached hereto) **must** be uploaded to Caselines or sent to STshetlho@judiciary.org.za and sello.tshetlho@webmail.co.za *by no later than 10h00 on the date of enrolment* (see paragraph [5] below). All the information required on Form 10 must be provided.
- [3] Practitioners are encouraged to also indicate the following on the Form 10:
 - [a] In the event that merits have not yet been settled and merits and quantum are to be separated, why the matter should continue on merits only;
 - [b] All expert reports already filed by plaintiff and/or defendant (other than Joint Minutes and Actuarial Reports specifically mentioned in Form 10);
 - [c] Outstanding expert reports still to be filed by plaintiff and/or defendant (other than Joint Minutes and Actuarial Reports specifically mentioned in Form 10);

- [d] When outstanding expert reports (other than Joint Minutes and Actuarial Reports specifically mentioned in Form 10) will be filed.
- [e] Any other issue not referred to above for consideration by the Judge.
- [4] Where a matter is simply to be removed from the roll, kindly indicate same.
- [5] Only Form 10's uploaded onto CaseLines will be considered. In the event that a Form 10 cannot be uploaded an arrangement can be made to e-mail it to STshetlho@judiciary.org.za. And sello.tshetlho@webmail.co.za
- [6] The roll for 05 to 9 October 2020 attached hereto. Forms may be uploaded in advance. Kindly indicate the date of enrolment as well as the roll number on the form, and in the event that a form is submitted via e-mail in the e-mail.
