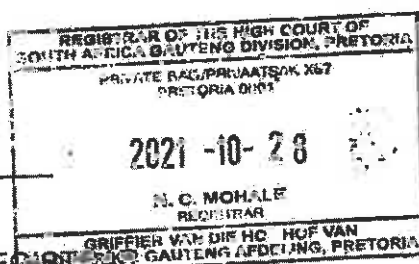

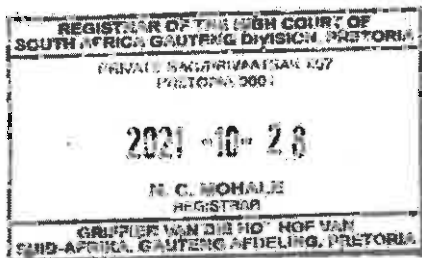
1. As noted that 1 November 2021 is a public holiday (date of municipal elections) all Civil Trial Matters allocated for this day are to be dealt with in the manner below.
