CASE MANAGEMENT CONFERENCE MATTERS:

- The CMC's will be done on paper – practitioners are to note the following:
 - a. if the pre-trial does not make provision for a separation of merits and quantum it will NOT be granted;
 - b. if the plaintiff has not filed a SIGNED discovery affidavit, the matter is not ready for trial;
 - c. if there is no proper pre-trial, the matter is not ready for trial;

- d. if any expert report is outstanding (other than that of the actuary), certification will be refused;
- e. The Form 10 is to be uploaded at the time that the other CMC documents are loaded. Any matter where no Form 10 is uploaded WILL BE REMOVED.

DEFAULT JUDGMENT COURT

- All Default Judgment court matters will be heard in open court and will commence as soon as the other rolls have been concluded. If counsel is not in court or the papers are not properly before court the matter will be removed from the roll.
