1. Kindly note that **settlements and default judgments will be heard IN OPEN COURT** before HAUPT AJ and all Counsel are to appear unless their matters have been disposed of and/or dealt with timeously in terms of 3.3 hereunder. The settlement roll will be called from **9h30** and the default judgment roll from **10h30**.
2. Haupt AJ will depose of **Case Management matters on the papers** uploaded on Caselines, no appearance is necessary unless further elaboration is required. All practitioners are to ensure that their **Form 10 in hard copy is hand delivered to the registrar** of HAUPT AJ, Ms Malebo Shongwe no later than **a day before the matter is to be heard**. The number and date on the roll must be indicated.
3. Please note the following:
 - 3.1 To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives.
 - 3.2 DRAFT ORDERS:

- Save for matters disposed of in terms of subparagraph 3.3 hereof, Counsel appearing should possess a **hard copy (in duplicate)** of the draft orders which they wish to move.
- Furthermore, if the draft orders pertain to a matter on the **settlement roll**, letters of confirmation by the Defendant that they have perused the terms of **THAT** draft order and are satisfied with the terms therein and the prescribed confirmatory affidavits in respect of contingency agreements, where applicable, must be provided failing which, the draft will not be made an order.
- **All draft orders must indicate** the date on which the matter was heard, the Judge's name (i.e., Haupt AJ), in which Court and, at the end of the draft order the party must indicate the name, chambers and contact details of their counsel and their instructing attorney.

- If any matter is to be removed, please ensure that such **notice is uploaded onto Caselines and emailed to MShongwe@judiciary.org.za a day before the matter is to be heard**, in which case the Counsel will be excused from appearing. If not, Counsel is to appear and remove the matter in open Court.

3.4 A practice note, stating the nature of the application, the date and number on the roll and contact details (including email address) of the legal practitioner, must be filed on Caselines and **a hard copy is to be hand delivered to the registrar, Ms Malebo Shongwe no later than a day before the matter is to be heard.**
