4. All counsel should be robed for the appearance.
5. Only the Counsel/attorney/applicant/respondent for the matter being called before the Judge will be allowed to have their computer's camera and microphone turned on. The rest of the counsel who are not appearing in the called matter will be requested to have their computer's camera turned off and the microphone muted.
6. Postponements and removals will be called first. Thereafter the applications will be called chronologically to the number appearing on roll.
7. Legal representatives should ensure that all relevant documents are uploaded to Caselines including the practice note, notice of set down and the draft order (in both Word and Pdf format in relation to the draft order).

8. The draft order which is uploaded must clearly reflect the surname of the Judge, date, the name of the counsel, the attorney and their respective e-mail addresses. If the phrase "Further and/or alternative relief" appears in your draft order it must be deleted.
9. All documents should be uploaded by 12:00 the previous court day of the hearing. It must be available on Caseline the day of the hearing.  
If the documents are not in order, the matter will be removed from the roll.
