2. Parties must bring **ONE hard copy of Draft Order/s** sought and ensure that a copy of same is uploaded onto Caselines as well.
3. **Draft Orders** must correctly indicate the Judge's name (i.e. **MOVSHOVICH AJ**), date on which the matter was heard, in which Court and at the bottom of the draft order the party(ies) must indicate the name and contact details of their counsel and their instructing attorney.
4. **A Practice Note** stating the nature of the application, the date and number on the roll and contact details (including email address) of the legal practitioner, must be filed on Caselines. All Practice Notes must be filed and uploaded by 14h00 on the day preceding the hearing of the matter.
5. During the open court hearing the following shall be adhered to:
 - 5.1. Introductions shall take place daily at **09h45** in office 4.8 at the

fourth floor.

- 5.2. Matters will be called in accordance with the order of the roll.
- 5.3. If a counsel is appearing in more than one matter on the roll, counsel is to call all the matters she/he appears in, in order to finalise counsel's roll as expeditiously as possible and for counsel to be excused from the court.
