Having heard counsel and having considered the documents delivered in the Interlocutory Court, it is ordered as follows:

1. Respondent is ordered to, within 5 days from service of this order on it, indicate in writing a date and time for purposes of holding a pre-trial conference and attend such conference, which date shall be no later than 15 days after service of this order.
2. The respondent is ordered to pay the costs of this application on an attorney and client scale.
3. In the event of the Respondent failing to comply with the order granted in paragraph 1 supra, the Applicant is granted leave to approach this court on the same papers, duly supplemented to indicate whether there was compliance or not by the Respondent, for an order in the following terms:
 - a. That the defence of the Respondent be struck out;
 - b. That leave be granted to the Applicant to approach the registrar for a date on the Default Judgment Roll and may proceed to obtain default judgment on the allocated date;

- c. That the Respondent be ordered to pay the costs of the application to struck out, on an attorney and client scale.
