3. Representatives must upload draft order/s and bring hardcopies to Court. Draft orders must correctly indicate the Judge's name (i.e. VAN ONSELEN AJ), date on which the matter was heard, in which Court and at the end of the draft order the party must indicate the name and contact details of their counsel and their instructing attorney.
4. Heads of argument must be as short and concise as possible. Kindly refrain from copying and pasting lengthy portions of the reports. Rather summarise the opinions of each expert without repetition.
5. If matters are not proceeding for whatever reason (i.e. defence entered, settled etc.) kindly IMMEDIATELY notify Mrs Msimango at ChMsimango@judiciary.org.za to avoid unnecessary perusal and preparation. If after hours the Judge can be notified on
