6. In order for your matter to be timeously considered, please ensure that all relevant documentation is uploaded to caselines by 12h00 on Friday, 23 June 2023.
7. Counsel/Practitioners appearing before the court should be robed for the hearing.
8. The decorum of the court is to be maintained at all times.
9. Settlements and removals will be considered on a case by case basis. Should you settle prior to your hearing, please ensure that a note is made on caselines advising the Judge of the status of the matter. In appropriate circumstances, an order may be granted without the need for an appearance
10. In matters where a curator ad litem has been appointed, please ensure that the curator has prepared a report and is present in court for the application, unless specifically excused.
