4. Matters will be heard according to the seniority of the counsel/attorney appearing in the matter ie. the practitioner who will be arguing the matter.
5. Matters that have become settled: A separate profile called **SETTLEMENT BUNDLE** must be created containing the following: Offer and acceptance Draft Order Confirmation letter in

respect of draft order - This is to ensure that another Court is not burdened with a matter that has already been read. Matters will not be stood down for settlement.

6. In the event of a **removal**: Counsel / the Attorney appearing in the matter must give a full explanation for the removal and why other matters that could have been finalised, were not able to be set down in its place. Prepare on costs. If necessary, an affidavit must be uploaded under a separate pocket **REMOVAL BUNDLE**.
