TO: ALL LEGAL PRACTITIONERS

FAMILY COURT DIRECTIVE: 22nd -26th MAY 2023

1. Kindly take note matters will be heard in open court 6 G.
2. Parties should ensure that all documents including draft orders and practice notes are filed on Caselines by no later than **Friday 19th of May 2023** close of business. Practice notes should set out, amongst others, legal practitioners' contact details (names, email addresses and contact numbers).
3. Draft orders must be in both word and pdf and should contain the courts' disclaimer, Judge's name (i.e. Collis J), manner of hearing and date of hearing.

4. Any settlement agreements where minor children are involved must already have been endorsed by the Family Advocate, and must be marked "Annexure" A".
5. Parties should ensure compliance with relevant directive pertaining to family court matters.
6. Take note that uploading of documents on Caselines outside of the stipulated times and without permission from the court will result in the matter being struck off the roll and costs *de bonis propriis* may be ordered against the errant practitioner.
7. Matters number 10,14 and 24 will be dealt with virtually during the course of next week and I will forward the link in due course.
