Practice Directive

- c. In all other divorce matters where proper affidavits have been filed, no oral evidence need to be led.
- d. Matters in which caselines documents were incomplete have been enrolled on Monday 22 May 2023. Should the hearing of those matters need to be on a different date, depending on the set-down thereof, Judge Davis' secretary must be informed thereof by e-mail, otherwise those matters might run the risk of being struck-off in the event of non-appearance on Monday 22 May 2023.
