1. The Honourable Judge KHUMALO (Ms) and the Honourable Judge HOLLAND-MUTER will be presiding over both the Family Court and Urgent Family Court for the period 09 to 13 October 2023.
2. Family Court matters are enrolled for the Monday of each week for that week. The Honourable Judge KHUMALO (Ms) will then place matters she presides over to specific dates in the week. Please contact the Judge's Registrar for the Honourable Judge HOLLAND-MUTER in this regard.
3. Urgent Family Court matters are enrolled for the Tuesday of each week for that week. The Honourable Judge KHUMALO (Ms) may then place matters she presides over to specified dates in the week. Please contact the Judge's Registrar for the Honourable Judge HOLLAND-MUTER in this regard..
4. The Family Court roll has been received and the matters to be adjudicated by Judge KHUMALO (Ms) appears below. The roll and directive of Judge Holland-Muter can be obtained from his Judge's Registrar.
5. The Urgent Family Court roll has as yet not closed and is therefore not available for circulation, this will be done in due course.



6. In the event that a party wishes to enrol an Urgent Family Court matter outside of the normal time frames. The writer hereof must first, before enrolling the matter with the Registrar's Office, be contacted to request enrolment. An enrolment and allocation does NOT mean that the matter is considered sufficiently urgent to hear on the merits. Submissions will need to be made regarding the grounds of urgency before the merits are heard.
7. Kindly be advised that the general Family Court Directives are to be STRICTLY complied with.
8. There will be no open court appearances
9. The unopposed divorces has been allocated to Tuesday 10 October 2023 and will be done on paper, no appearances are necessary unless other directed by The Honourable Judge KHUMALO (M).
10. The Opposed matters have been allocated to Wednesday 11 October 2023 and will be heard virtually via MS Teams.
11. The MS Teams links for the week can be found at the bottom hereof.
12. Litigants must be robed when appearing on the virtual platform, mute themselves when they are not arguing but remain visible at all times when their matter is being heard. The decorum of the court is to be maintained at all times.
13. The hearings will be in accordance with allocations as set out on the roll attached below. Legal practitioners, and their clients as applicable, are required to log on to the MS Teams at least 30min before the commencement thereof in order to attend to possible technical difficulties.
14. Matters must be accessible on Caseline in order to be adjudicated. The onus lies on Litigants to ensure this.
15. A Practice Note and Joint Practise Note, when opposed, comprehensively indicating the issues to be decided upon in the matter should have been filed and accessible on Caseline. Non-Compliance will result in the matter being removed from the roll, due to papers not being in order, without the matter being called.
16. Draft Orders, both in MS Word and PDF formats, containing the relieve sought must be both filed and emailed to the Judge's Registrar. **Draft Orders must indicate the correct date and Judge's name as follows: THE HONOURABLE MADAM JUSTICE KHUMALO. Representative full details and contract particulars must appear at the**



bottom thereof. In the event that Draft Orders need to be amended, as per the Judge's instruction, litigant are required to BOTH file and email such the same day. The matter will not be considered disposed of otherwise.

No further documents are to be uploaded after the cut-off time indicated in the practice manual as read with the practice directive of this court unless with the express permission of the Honourable Judge Khumalo (Ms) this excludes updated Draft Orders.
