1. Kindly take note that there will be no open court appearances. All matters will be dealt with by way of videoconferencing through Microsoft Teams.
2. Parties should ensure that heads of argument and practice notes are filed on Caselines no later than 8 July 2022. Practice notes should set out, amongst others, legal practitioners' contact details (names, email addresses and contact numbers).
3. Parties should ensure compliance with relevant directives pertaining to delivery and uploading of both parties' Heads of Argument or court orders obtained through an Application to Compel.
