TERM 3: OPPOSED MOTIONS

MINNAAR AJ: 4 SEPTEMBER 2023 TO 8 SEPTEMBER 2023

5. The parties are directed to ensure that a **joint practice note** is uploaded onto CaseLines no later than **Wednesday 30 August 2023** containing the following:

5.1 Names of the parties and the case number

5.2 Names and telephone numbers of all counsel in the motion.

5.3 Nature and brief summary of the motion.

5.4 Relief sought at the hearing by the party on whose behalf counsel is appearing.

5.5 An estimate of the probable duration of the application.

5.6 Number of pages in the application and whether all the papers need to be read and if not, which portion need not be read.

6. Should a matter for any reason not proceed on the given date, you are directed to inform the office of Judge Minnaar via email to Erikhotso@judiciary.org.za.
7. Non availability of counsel representing any of the parties will not be allowed as a reason for the matter not to proceed on the allocated date of the hearing.
