DIRECTIVE BY THE HONOURABLE MADAM JUDGE TOLMAY

1. All matters will be heard before Honorable Madam Judge Tolmay, Honorable Acting Judge Mathunzi, Honorable Acting Judge Marumoagae and Honorable Acting Madam Judge Coetzee.
2. All matters before Honorable Madam Judge Tolmay will be heard in open court.
3. All relevant documents including the practice note, heads of argument and draft orders must be uploaded onto Caselines. Bundles must be marked - i.e “opposed motion bundle” - and annexures must be chronologically and clearly marked to describe their contents - i.e “A – Notice of Motion”.
4. **Any uploading of additional documents must be done only with the permission of the Judge to whom the matter is before.**

5. Any postponements, settlements and/or removals must be communicated with the relevant Registrar of the Judge to whom the matter is allocated.
