1. Please note that the matters referred to in the below Opposed Motions Roll have been allocated to Movshovich AJ.
2. Matters will be heard in Open Court. Parties will be informed of the court room in due course.
3. The joint practice note in each matter must be uploaded onto Caselines **by 17:00 on Tuesday, 4 April 2023**. Counsel are requested to ensure that the joint practice note deals with all aspects identified in paragraph 154 of the Judge President's Revised Consolidated Directive, 2 of 2022 and that the parties advise whether they are in agreement regarding the mode of hearing. If the parties suggest a different mode of hearing, this should be fully motivated in the joint practice note.
4. Please note:
 - 4.1. The parties are responsible for ensuring compliance of the matter with all relevant directives, so that the matter may be heard without further preparatory or collateral processes having to be followed.
 - 4.2. Parties should ensure that proposed draft orders are uploaded onto Caselines and emailed in Word format to ChMsimango@judiciary.org.za at least the day before a particular matter will be heard. Draft orders should indicate the hearing date of the matter, the Judge's name, and the manner in which the matter will be heard, and at the end of the draft order the names and details

of all counsel/practitioners and of their instructing attorneys must be included.

4.3. In the event that matters are to be removed, postponed or become settled, the parties must communicate this by email with the necessary notices/draft order without delay to ChMsimango@judiciary.org.za.

5. Once the joint practice notes are delivered (or the time to do so expires), a further court roll will be published.
