The opposed motions will be dealt with as follows:

1. All matters will be heard via **MICROSOFT TEAMS**.
2. The link will be sent to the Bar Associations for the attention of the Legal Practitioners (LPs).
3. LPs are advised to be in attendance from 10h00 on all the above mentioned dates.
4. Papers are to be properly indexed and paginated with a Practice Note in line with the latest Practice Directive, dated 11 June 2021. If this is not done your matter will be struck from the roll.

5. Failure to file a Practice Note(s) and/or Heads of Argument timeously, will be an indication that there is no appearance for the party concerned and the application may then either be struck off the roll or be dealt with in the absence of such party.
6. On the question of the Practice Note, a deficient Practice Note will be disregarded and your matter will still be removed. LPs are to refer to the Practice Manual and the Judge President's prevailing directives.
7. The Practice Note must indicate at least the following (to assist the Judge in her preparation):
 - 7.1 Particulars and contact details of the legal practitioners;
 - 7.2 Nature of the relief sought (without referring to the notice of motion);
 - 7.3 Total number of pages;
 - 7.4 A brief summary of the factual as well as legal issues involved;
 - 7.5 A clear indication (without referring to the heads of argument) which portion of the papers must be read and which not;
 - 7.6 The main issues to be considered; and
 - 7.7 Estimated duration
8. Failure to file a Practice Note setting out all the above information paragraph by paragraph individually, may result in the application be struck off the roll and a punitive cost order be granted.
9. LPs are to refrain from contacting the Judge directly, either by way of an email, WhatsApp or phone.
