DIRECTIVE:

- 1. All hearings shall be conducted in open court**
- 2. Removals, postponement and settlement will be called first thereafter matters will be called in terms of seniority.**
- 3. All Draft Orders must indicate** the date on which the matter was heard, the Judge's name (i.e. **Khwinana AJ**), in which Court and, at the end of the draft order the party must indicate the name, chambers and contact details of their counsel and their instructing attorney.
- 4. A hard copy of draft order must be handed up in court.**
- 5. A practice note**, stating the nature of the application, the date, duration and number on the roll and contact details (including email address) of the legal practitioner, must be filed on Caselines.

6. **Masks** to be worn and **social distancing** to be kept amongst counsel appearing. The same applies to individuals/ attorneys sitting in the gallery. Counsel may remove her/his mask when addressing the Court
7. Introductions shall take place in court and not in chambers.
8. If a counsel is appearing in more than one matter on the roll, counsel is to call all the matters she/he appears in, in order to finalise counsel's roll as expeditiously as possible and for counsel to be excused from the court.
9. Parties to identify documents uploaded and to upload documents individually.
10. Counsel must file heads of argument on or before the day preceding date of hearing. (**late filing/uploading of heads for tomorrow's matter will be allowed until the end of business today**)
