1. Kindly note that ALL the applications will be heard IN OPEN COURT, COURT 4 C before the Honourable Relief AJ on the 22, 24 AND 26 AUGUST 2022 and ALL Counsel are to appear unless their matters have been disposed of and/or dealt with timeously in terms subparagraph 2.3 hereof.
2. In the interim and to assist the above-mentioned Judge, please note the following:
 - 2.1. To assist the Judge in the deliberation of the matters on her roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives pertaining to unopposed motions.
 - 2.2. Save for matters disposed of in terms of subparagraph 2.3 hereof, parties **MUST HAND-UP** the proposed draft orders on the day that a particular matter is to be allocated and heard.
