DIRECTIVE FOR THE UNOPPOSED APPLICATIONS ROLL BEFORE DE VOS AJ –
02 SEPTEMBER 2022

1. Kindly find the attached Unopposed Applications for matters to be dealt with by Acting Judge De Vos on Friday, 02 September 2022.
2. Kindly take note that there will be **open court appearances**. The Court will commence at 10h00 at Gauteng Division, Pretoria **Court 4C**. Kindly be at court **09h40** in order, to ensure that we are ready to commence at 10h00 and also to do introductions.
3. In order for the court to consider the matter, parties should ensure that the pleadings, **Practice Note**, **Notice of Set down** and **Draft Court Order** are **uploaded onto Caselines**. The Draft Court Order should set out the **date of hearing**, **Judge's name** (i.e Acting Judge De Vos) and the manner in which the **matter will be heard** (i.e Court 4C), and name and details of Counsel/Practitioner and those of the instructing attorney should appear at the end of the draft.
4. The Counsels/Attorneys moving the application should bring a **copy of the Court Order** similar to the one **uploaded onto Caselines** for the Judge to sign if the Court is satisfied with the application.

5. Attorneys for the Applicant should also ensure that a **compliance declaration** is uploaded onto **Caselines**, failing which the matter will be removed from the roll.
