DIRECTIVE:

HARD COPY OF PAPERS FILED

1. The attorney on behalf of the party that enrolled the matter is to ensure that a **hard copy of the full set of indexed and paginated papers (as on Caselines) together with the practice note (and if applicable heads of argument) filed** is delivered to the Registrar of Haupt AJ (Office 6.8, 6th Floor High Court Building) as follows:
 - 1.1. Matters enrolled for-
 - 1.1.1. 20 December: **on/before 12h00 on Thursday, 15 December**
 - 1.1.2. 22 December 2022: **on/before 10h00 on Monday, 19 December**
 - 1.2. The hard copy need not be in a court file but must on the front page indicate the date and number on the roll. Copies may be printed on both sides of the page.
 - 1.3. The **final enrolment and proof of service of the notice of set down on the respondent** must be included. Proof of service of the notice of set down on **Respondents in all unopposed divorces** is required.

- 1.4. The hard copy of the papers will be returned and available for collection from the Registrar of Haupt AJ on 22 December 2022 or such date as arranged with the Registrar.

HARD COPIES OF DRAFT ORDERS:

2. **Draft orders** are to be emailed in Word Format to JMagoro@judiciary.org.za
The date and number on the roll is to be indicated in the email.
3. Two hard copies of the draft order must be handed up when the matter is called.
4. Draft orders should contain a disclaimer, indicate the date of hearing, Judges' names (i.e Haupt AJ), the manner of hearing (i.e Open Court) and the name and details of Counsel for Applicant and those of the instructing attorney. For example:

"DISCLAIMER: This Order is made an Order of Court by the Judge whose name is reflected hereon, duly stamped by the Registrar of the Court and is submitted electronically to the parties or their legal representatives by e-mail. This Order is further uploaded to the electronic file of this matter on Case Lines by the Judge's Registrar. The date of this Order is deemed to be 20 December 2022.

FREEZING OF COURT FILES:

5. **COUNSEL/PRACTITIONERS SHOULD ENSURE THAT ALL DOCUMENTS ARE FILED ON CASELINES BY NO LATER THAN 16H00, TWO COURT DAYS BEFORE THE DATE OF HEARING. NO LATE UPLOADING OF DOCUMENTS WILL BE ALLOWED.**

OPEN COURT HEARINGS

6. All hearings shall be conducted in **open court as follows** except for the matters referred to in 7 hereunder in the following:
 - 6.1. **Rule 43 applications and ex parte applications shall be heard from 9h00 to 10h00**
 - 6.2. **Unopposed involving minor children or major children who are not yet self-supporting** shall be heard from **10h00** together with removals postponements, and draft orders.
 - 6.3. **All other matters** shall be heard after the matters referred to in 6.2
 - 6.4. Summary judgments stand down until the end of the roll.
 - 6.5. A hard copy (in duplicate) of draft orders must be handed up as referred to in 3 and 4 above.
7. Divorces not involving children as referred to in 6.2 above, shall be decided on the papers filed and no appearance is required.
8. With reference to 6.3 above, kindly take further note that Court will start with removals, settlements, and postponements, thereafter, the matters will be called page by page in order of Seniority as matters appear on the roll.
9. If a counsel is appearing in more than one matter on the roll, counsel is to call all the matters she/he appears in, in order to finalise counsel's roll as expeditiously as possible and for counsel to be excused from the court.
10. Failure to comply with this directive may result in the matter being removed from the roll and disallowance of the legal representatives' costs.
