CASELINES:

- If a draft order is sought on the Caselines note, it is to be emailed to NNair@judiciary.org.za in word format by no later than 13h00 the day prior to the hearing, with your roll number and the date in the subject line of the email.
- Failure to do so will cause the matter to be removed.

IN PERSON LITIGANTS:

- In the event that there are parties in person for the matter – those parties must attend court and proceed to the 6th floor courtroom – court 6F / 6G where they will be assisted with the virtual hearing.
