- 5.3 The legal submissions and the legal authorities the applicant is relying on;
- 5.4 Rule 46A applications must cover the issues identified by the full court in the *Mokebe*¹ judgment; and
- 5.5 Where there is an unrepresented opponent, it is the responsibility of counsel to draw the court's attention to that fact.

6. LPs are to refrain from contacting the Judge directly, either by way of an email, WhatsApp or phone.
