1. Kindly note that matters will be adjudicated on paper and some will be heard virtually before the Honourable Baloyi-Mere AJ in the week of 03rd – 07th October 2022 and link will be sent to all practitioners a day before each hearing.
2. Legal Practitioners will be informed timeously should the attendance be required on Ms Teams.
3. Legal practitioners are requested to login unless where they have been informed that their matters have been dealt with on paper.

4. Legal practitioners are requested to upload a practice note, stating the nature of the application, the date, the number on the roll and the contact details (including email address) of the legal practitioner on Caselines.
5. Legal practitioners are requested to upload a draft order in Microsoft Word format depicting the name of the Judge (i.e Baloyi-Mere AJ), date on which the matter was heard and at the end of the draft indicate the name and contact details of the counsel (if any) and instructing attorney.
6. Stamped and signed draft orders will be uploaded on Caselines as soon as they have been signed.
7. The roll will be dealt with as follows, postponements, removals and settlements may be called first as well as noting of appearance in opposed matters. Thereafter the roll will proceed in order of seniority and any opposed matter will be dealt with at the end of the roll.
8. In the event where matters are removed or have become settled, the legal practitioners need to inform the Judge's secretary before the hearing and preferably within a minimum of 24 hours before the date of the hearing by sending an email and uploading such on Caselines. Parties are encouraged to ensure compliance with the relevant practice directive to prevent matters from being struck off the roll. Any uploading of documents on Caselines should be done in line with the practice directive and should be completed before the Judge receives the roll, save for matters that will be removed or postponed
