 - 3.1 The parties are urged to clearly state what type of the application is to be dealt with in the Practice Note (i.e. Summary Judgement, Rule 43 etc.) and which section(s) is the application uploaded (i.e. section 002-007).

- 3.2 To assist the Judge in the deliberation of the matters on his roll and to prevent matters from being struck, parties should ensure compliance with the relevant practice directives pertaining to unopposed motions.
- 3.3 Save for matters disposed of in terms of subparagraph 3.4 hereof, parties should print out **1 (one) copy** of the **Draft Order and other attachments (i.e settlement agreements, deed of trust)** if any.
