Directive for matters to be heard by Van der Schyff J [Bam J will issue a separate directive for matters allocated to be heard by her]

1. Please note that the complete roll follows, *infra*, and that the allocation to the respective judges is indicated on the roll. The following directive pertains to matters allocated to Judge van der Schyff.
2. All matters will be dealt with in open court.
3. All unopposed divorces will be heard on Monday, 24 July 2023, from 10h00, or as soon thereafter as matters can be called. *Viva voce* evidence must be led.
4. Rule 43 applications will be heard on Tuesday, 25 July 2023, unless a written request is made for the matter to be heard on a different day.
5. Two copies of draft orders, and two copies of settlement agreements, together with the original settlement agreement, must be handed up when unopposed divorce matters are called. The original settlement agreement can be uplifted after an order is granted.
6. Where the interests of minor children are involved, settlement agreements must be endorsed by the Office of the Family Advocate. Settled divorce matters will also be dealt with in open court, and evidence must be led. All the required documentation pertaining to Rule 43 applications need to be filed timeously.
7. Counsel is requested to have regard to the 'Widely Shared Note' function on CaseLines as queries may be raised using this function prior to the hearing date.
8. Communication with this office must be done by **email** to Mr. S Tshetlho (stshetlho@judiciary.org.za).
9. **All urgent matters must be uploaded to CaseLines. Judge Van der Schyff's registrar must be contacted when urgent applications are to be allocated. The fact that an application is allocated does not mean that the issue of urgency became moot.**
