1. Attached to this directive is the unopposed motion roll of 16 January 2023.
2. The unopposed motion roll of Monday 16 January 2023, Wednesday 18 January 2023 and Friday 20 January 2023 will be called **physically in court 8A and the hearing will begin strictly at 10:00.**
3. Counsel are required to appear in all the applications and should be properly robed for the appearance.
4. Counsel must introduce themselves to the Judge at 09:45 if they haven't appeared before the Judge before. They can attend to room 8.10 for this purpose.
5. Postponements and removals will be called first. Thereafter the applications will be called in order of seniority.
6. Legal representatives should ensure that all relevant documents are uploaded to CaseLines/Court Online including the practice note, notice of set down and the draft order (in Word format) by 16:00 two court days prior to the hearing of the matter i.e. for matters enrolled for 16 January 2023 to be uploaded by 16:00 on

Thursday 12 January 2023, matters enrolled for 18 January 2023 to be uploaded by 16:00 on Monday 16 January 2023 and matters enrolled for 20 January 2023 to be uploaded by 16:00 on Wednesday 18 January 2023.

7. **Counsel are required to bring ONE hard copy of the draft order to court. Please ensure that the Judge's name is correctly reflected on the draft order as well as the date and the case particulars (i.e. case name and case number).**
8. The draft order which is uploaded must clearly reflect the surname of the Judge, date, the name of the counsel, the attorney and their respective e-mail addresses. If the phrase "Further or/and alternative relief" appears in your draft order it must be deleted. If the draft order refers to a settlement agreement or annexure one hard copy of the settlement agreement or annexure should also accompany the draft order.
9. If the documents are not in order or timeously uploaded, the matter will be removed from the roll. No late documents may be uploaded. Please upload all the documents on Caselines or Court Online.
