DIRECTIVE WITH REGARD TO URGENT COURT**17 – 20 OCTOBER 2023 BEFORE****JUDGE HOLLAND-MUTER**

1. **There shall be physical hearing at Court 4C at 10h:00.** Virtual hearing will be conducted only for matters lodged afterhours, weekends, public holiday and parties must arrange with the secretary working afterhours for a link.
2. Introductions before Judge Holland-Muter will be conducted at 09h:45, Office 5.5 on 5th Floor
3. In accordance with paras 172 to 183 of the directive of 11 June 2021, complete papers must have been filed by the preceding Thursday at 12h00. If the papers are not complete, an explanation must be given on affidavit. Parties may not simply upload further/supplementary affidavits to CaseLines without the leave of Court first having been obtained.

4. A practice note must be filed by all parties appearing in a matter, dealing specifically with urgency, giving a brief synopsis of the matter, and outlining the issues to be decided. The practice note shall be filed on CaseLines by no later than **16h00** on **Friday 13 October 2023**. Draft orders must also be uploaded. The practice note must specifically state which part of the record must be read, and which not. The parties must see to it that the record is loaded on CaseLines in a logical and easily readable format. Annexures to affidavits must be individually listed, and not simply as “Annexures to....”.
5. Parties shall deliver hard copies of their **Heads of Argument, List of Authorities** if any and **1 Copy of the proposed Draft orders** to the allocated Judge’s Registrar by Monday 16 October 2023 at 10h00.
6. Failure to comply with this directive may lead to the matter being struck from the roll.
7. Matters are allocated with specific dates and parties must appear on the date allocated. Save for matters that became settled parties can attend court on Tuesday regardless of the date allocated. Parties have until Monday the 16th October before the close of business to email their requests for date preferences to zmsimanga@judiciary.org.za and same request must be substantiated with reasons.
